Long-term financing of a company; Short-term planning and control. Financial analysis and techniques of financial analysis; Central bank, business banks. Insurance companies and other financial institutions. Introduction to public finance. <i>Practical course work</i> Financial function in an enterprise and its role; Rules of financing (horizontal and vertical); Forms of business financing; Financial planning and control; Basics of financial assessment and ranking of investment projects; Characteristics of financial and foreign exchange market; Systems of exchange rate; Principles of banking operations and types and forms of banking operations; Basics of system of life and non-life insurance; Public incomes and expenses.
